PART I. GENERAL INTRODUCTION

I.O. About the teacher's guide

This book is a teacher's guide for ICT in Accounting subject for Senior Four in Accounting program. It is designed to complement and accompany the student book and intends to help teachers in the implementation of the competence based curriculum specifically ICT in Accounting syllabus.

As the name says, it is a guide that teachers can refer to when preparing their lessons. Teachers may prefer to adopt the guidance provided but they are also expected to be more creative and consider their specific classes' contexts and prepare accordingly.

I.1. The structure of the guide

This section presents the overall structure, the unit and sub-heading structure to help teachers to understand the different sections of this guide and what they will find in each section.

Overall structure

The whole guide has three main parts as follows:

❖ Part I: General Introduction.

This part provides general guidance on how to develop the generic competences, how to integrate cross cutting issues, how to cater for students with special educational needs, active methods and techniques of ICT and guidance on assessment.

❖ Part II: Sample lesson plan

This part provides a sample lesson plan, developed and designed to help the teacher develop their own lesson plans.

❖ Part III: Unit development

This is the core part of the guide. Each unit is developed following the structure below. The guide ends with references.

Each unit is made of the following sections:

- Unit title: from the syllabus
- Key unit competence: from the syllabus

Prerequisites (knowledge, skills, attitudes and values)

This section indicates knowledge, skills and attitudes required for the success of the unit. The competence-based approach calls for connections between units/topics within a subject and interconnections between different subjects. The teacher will find an indication of those prerequisites and guidance on how to establish connections.

- Cross-cutting issues to be addressed

This section suggests cross cutting issues that can be addressed depending on the unit content. It provides guidance on how to come up with the integration of the issue. Note that the issue indicated is a suggestion; teachers are free to take another cross-cutting issue taking into consideration the learning environment.

Guidance on the introductory activity

Each unit starts with an introductory activity in the teacher's book. This section of the teacher's guide provides guidance on how to conduct this activity and related answers. Note that students may not be able to find the right solution but they are invited to predict possible solutions or answers. Solutions are provided by students gradually through discovery activities organized at the beginning of lessons or during the lesson.

- List of lessons/sub-heading

This section presents in a table suggestions on the list of lessons, lesson objectives copied or adapted from the syllabus and duration for each lesson. Each lesson /subheading is then developed.

- End of each unit

At the end of each unit the teacher provides the following sections:

- Summary of the unit which provides the key points of content developed in the teacher's book.
- Additional information which provides additional content compared to the student book for the teacher to have a deeper understanding of the topic.
- End unit assessment which provides answers to questions of the end unit assessment in the teacher's book and suggests additional questions and related answers to assess the key unit competence.
- Additional activities: (remedial, consolidation and extended activities).
 The purpose of these activities is to accommodate each student (slow, average and gifted) based on the end of unit assessment results.

Structure of each sub heading

Each lesson/sub-heading is made of the following sections:

Lesson /Sub heading title 1:

- Prerequisites/Revision/Introduction:

This section gives a clear instruction to teacher on how to start the lesson.

- Teaching resources

This section suggests the teaching aids or other resources needed in line with the activities to achieve the learning objectives. Teachers are encouraged to replace the suggested teaching aids by the available ones in their respective schools and based on the learning environment.

- Learning activities

This section provides a short description of the methodology and any important aspect to consider. It provides also answers to learning activities with cross reference to student's book.

- Exercises/application activities

This provides questions and answers for exercises/ application activities.

I.2. Methodological guidance

I.2.1. Developing competences

Since 2015 Rwanda shifted from a knowledge based to a competence based curriculum for pre-primary, primary and general secondary education. For Accounting, it is in 2021 that the competence based curriculum was embraced. This called for changing the way of learning by shifting from teacher centered to a learner centered approach. Teachers are not only responsible for knowledge transfer but also for fostering teacher's learning achievement, and creating safe and supportive learning environment. It implies also that a student has to demonstrate what he/she is able to do using the knowledge, skills, values and attitude acquired in a new or different or given situation.

The competence-based curriculum employs an approach of teaching and learning based on discrete skills rather than dwelling on only knowledge or the cognitive domain of learning. It focuses on what learner can do rather than what learners know. Students develop basic competences through specific subject unit competences with specific learning objectives broken down into knowledge, skills and attitudes. These competences are developed through learning activities disseminated in learner-centered rather than the traditional

didactic approach. The students are evaluated against set standards to achieve before moving on.

In addition to specific subject competences, students also develop generic competences which are transferable throughout a range of learning areas and situations in life. Below are examples of how generic competences can be developed in ICT in Accounting:

I.2.2. Addressing cross cutting issues

Among the changes in the competence based curriculum is the integration of cross cutting issues as an integral part of the teaching learning process-as they relate to and must be considered within all subjects to be appropriately addressed. The eight cross cutting issues identified in the national curriculum framework are: genocide studies, environment and sustainability, gender, Comprehensive Sexuality Education (CSE), Peace and Values Education, Financial Education, standardization Culture and Inclusive Education.

Some cross cutting issues may seem specific to particular learning areas or subjects but the teacher needs to address all of them whenever an opportunity arises. In addition, student should always be given an opportunity during the learning process to address these cross cutting issues both within and out of the classroom so as to progressively develop related attitudes and values.

Below are examples on how crosscutting issues can be addressed in ICT in Accounting:

Cross-cutting issues	Examples on how to integrate the cross- cutting issues
Inclusive education	Involve all students in all activities without any bias.
	Eg: Allow a student with physical disability (using wheelchair) to take notes or lead the team during an experiment.
Gender	Involve both girls and boys in all activities: No activity is reserved only to girls or boys.
	Teacher should ensure equal participation of both girls and boys during experiments as well as during cleaning and tidying up related activities after experiments.
Peace and Values Education	During group activities, debates and presentations, the teacher will encourage students to help each other and to respect opinions of colleagues.

Standardization culture	 Most ICT in Accounting require the use of software. Students should always be aware to use standard software products and use standard software
	 In addition, when using the different software students have to record data accurately.
	 For tasks involving calculations, they have to always present accurate results.
Environment and sustainability	 In order to avoid the environment pollution, students avoid throwing ICT materials away anywhere; special places or appropriate containers should be used.
	 Students also have to be aware of the impacts of the use of some products like cartridges, plastic components of ICT tools on the environment.
Financial Education	When performing experiments, students are encouraged to avoid wasting chemicals by using the quantities that are just required. They are required to also avoid spoiling equipments and other materials

I.2.3. Attention to special educational needs specific to each subject

In the classroom, students learn in different ways depending to their learning pace, needs or any other special problem they might have. However, the teacher has the responsibility to know how to adopt his/her methodologies and approaches in order to meet the learning needs of each student in the classroom. Also the teacher must understand that students with special needs need to be taught differently or need some accommodations to enhance the learning environment. This will be done depending on the subject and the nature of the lesson.

In order to create a well-rounded learning atmosphere, the teacher needs to:

- Remember that students learn in different ways so they have to offer a variety of activities (e.g. role-play, music and singing, word games and quizzes, and outdoor activities).
- Maintain an organized classroom and limits distraction. This will help students
 with special needs to stay on track during lesson and follow instruction easily.
- Vary the pace of teaching to meet the needs of each student. Some students process information and learn more slowly than others.

- Break down instructions into smaller, manageable tasks. Students with special needs often have difficulty understanding long-winded or several instructions at once. It is better to use simple, concrete sentences in order to facilitate them understand what you are asking.
- Use clear consistent language to explain the meaning (and demonstrate or show pictures) if you introduce new words or concepts.
- Make full use of facial expressions, gestures and body language.
- Pair a student who has a disability with a friend. Let them do things together and learn from each other. Make sure the friend is not over protective and does not do everything for the student. Both students will benefit from this strategy.
- Use multi-sensory strategies. As all students learn in different ways, it is important to make every lesson as multi-sensory as possible. Students with learning disabilities might have difficulty in one area, while they might excel in another. For example, use both visual and auditory cues.

Below are general strategies related to each main category of disabilities and how to deal with every situation that may arise in the classroom. However, the list is not exhaustive because each student is unique with different needs and that should be handled differently.

Strategy to help students with developmental impairment:

- Use simple words and sentences when giving instructions.
- Use real objects that the student can feel and handle, rather than just working abstractly with pen and paper.
- Break a task down into small steps or learning objectives. The student should start with an activity that she/he can do already before moving on to something that is more difficult.
- Gradually give the student less help.
- Let the student work in the same group with those without disability.

Strategy to help students with visual impairment:

- Help students to use their other senses (hearing, touch, smell and taste) to play and carry out activities that will promote their learning and development.
- Use simple, clear and consistent language.
- Use tactile objects to help explain a concept.
- If the students has some sight, ask them what they can see. Get information from parents/caregivers on how the student manages their remaining sight at home.
- Make sure the student has a group of friends who are helpful and who allow the students to be as independent as possible.

Plan activities so that students work in pairs or groups whenever possible.

Strategy to help students with hearing impairment:

- Strategies to help students with hearing disabilities or communication difficulties
- Always get the students attention before you begin to speak.
- Encourage the student to look at your face.
- Use gestures, body language and facial expressions.
- Use pictures and objects as much as possible.
- Ask the parents/caregivers to show you the signs they use at home for communication use the same signs yourself and encourage other students to also use them.
- Keep background noise to a minimum.

Strategies to help children with physical disabilities or mobility difficulties:

- Adapt activities so that student who use wheelchairs or other mobility aids, or other students who have difficulty moving, can participate.
- Ask parents/caregivers to assist with adapting furniture e.g. The height of a table may need to be changed to make it easier for a student to reach it or fit their legs or wheelchair under.
- Encourage peer support friends can help friends.
- Get advice from parents or a health professional about assistive devices.

I.2.4. Guidance on assessment

Each unit in the teacher's guide provides additional activities to help students achieve the key unit competence. Results from assessment inform the teacher which student needs remedial, consolidation or extension activities. These activities are designed to cater for the needs of all categories of learners; slow, average and gifted learners respectively.

Assessment is an integral part of teaching and learning process. The main purpose of assessment is for improvement. Assessment for learning/ **Continuous/formative assessment** intends to improve students' learning and teacher's teaching whereas assessment of learning/summative assessment intends to improve the entire school's performance and education system in general.

Continuous/ formative assessment

It is an ongoing process that arises out of interaction during teaching and learning process. It includes lesson evaluation and end of sub unit assessment. This formative assessment plays a big role in teaching and learning process. The teacher should encourage individual, peer and group evaluation of the work done in the classroom and uses appropriate competence-based assessment approaches and methods.

In Senior Four textbook, formative assessment principle is applied through application activities that are planned in each lesson to ensure that lesson objectives are achieved before moving on. At the end of each unit, the end unit assessment is formative when it is done to give information on the progress of students and from there decide what adjustments need to be done. Assessment standards are taken into consideration when setting tasks.

Summative assessment

The assessment done at the end of the term, end of year, is considered as summative. The teacher, school and parents are informed on the achievement of educational objectives and think of improvement strategies. There is also end of level/ cycle assessment in form of national examinations.

I.2.5. Students' learning styles and strategies to conduct teaching and learning process

There are different teaching styles and techniques that should be catered for. The selection of teaching method should be done with the greatest care and some of the factors to be considered are: the uniqueness of subjects, the type of lessons, the particular learning objectives to be achieved, the allocated time to achieve the objective, instructional materials available, the physical/sitting arrangement of the classroom, individual students' needs, abilities and learning styles.

There are mainly four different learning styles as explained below:

a) Active and reflective learners

Active learners tend to retain and understand information best by doing something active with it, discussing or applying it or explaining it to others. Reflective learners prefer to think about it quietly first.

b) Sensing and intuitive learners

Sensing learners tend to like learning facts while intuitive learners often prefer discovering possibilities and relationships. Sensors often like solving problems by well-established methods and dislike complications and surprises; intuitive learners like innovation and dislike repetition.

c) Visual and verbal learners

Visual learners remember best what they see (pictures, diagrams, flow charts, time lines, films, demonstrations, etc); verbal learners get more out of words (written and spoken explanations).

d) Sequential and global learners

Sequential learners tend to gain understanding in linear steps, with each step following logically from the previous one. Global learners tend to learn in large jumps, absorbing material almost randomly without seeing connections, and then suddenly "getting it."

I.2.6. Teaching methods and techniques that promote the active learning

The different student learning styles mentioned above can be catered for, if the teacher uses active learning whereby students are really engaged in the learning process.

What is Active learning?

Active learning is a pedagogical approach that engages students in doing things and thinking about the things they are doing. In active learning, learners are encouraged to bring their own experience and knowledge into the learning process.

The role of the teacher in active learning

- The teacher engages students through active learning methods such as inquiry methods, group discussions, research, investigative activities and group and individual work activities.
- He/she encourages individual, peer and group evaluation of the work done in the classroom and uses appropriate competence-based assessment approaches and methods.
- He provides supervised opportunities for students to develop different competences by giving tasks which enhance critical thinking, problem solving, research, creativity and innovation, communication and cooperation.
- Teacher supports and facilitates the learning process by valuing students' contributions in the class activities.

The role of learners in active learning

Learners are key in the active learning process. They are not empty vessels to fill but people with ideas, capacity and skills to build on for effective learning.

A learner engaged in active learning:

- Communicates and shares relevant information with other learners through presentations, discussions, group work and other learner-centred activities (role play, case studies, project work, research and investigation)
- Actively participates and takes responsibility for their own learning
- Develops knowledge and skills in active ways
- Carries out research/investigation by consulting print/online documents and resourceful people, and presents their findings
- Ensures the effective contribution of each group member in assigned tasks through clear explanation and arguments, critical thinking, responsibility and confidence in public speaking
- Draws conclusions based on the findings from the learning activities.

Some active techniques that can be used in ICT in Accounting

The teaching methods strongly emphasised in the Competence Based Curriculum (CBC) are active methods. Below are some active techniques that apply in sciences:

A. Practical work/ experiments:

Many of the activities suggested in ICT in Accounting curriculum as well as in the teacher's book are practical works or experiments.

Practical work is vital in learning ICT in Accounting; this method gives the student the opportunity to implement a series of activities and leads to the development of both cognitive and hands-on skills. The experiments and questions given should target the development of the following skills in students: Observation, Recording and Report writing, Manipulation, Measuring, Planning and designing.

A practical lesson/Experiment is done in three main stages:

- **Preparation of experiment:** Checking materials to ensure they are available and at good state; try the experiment before the lesson; think of safety rules and give instructions to lab technician if you have any.
- **Performance of experiment:** Sitting or standing arrangement of students; introduction of the experiment: aims and objectives; setting up the apparatus; performing the experiment; write and record the data.
- Discussion: Observations and interpreting data; make generalisations

and assignment: writing out the experiment report and further practice and research.

In some cases, demonstration by the teacher is recommended when for example the experiment requires the use of sophisticated materials or very expensive materials or when safety is a major factor like dangerous experiments and it needs specific skills to be learnt first.

In case your school does not have enough laboratory materials and chemicals, experiments can be done in groups but make sure every student participates. You can also make arrangements with the neighbouring science school and take your students there for a number of experiments.

B. Research work

Each student or group of students is given a research topic. They have to gather information from internet, available books in the library or ask experienced people and then the results are presented in verbal or written form and discussed in class.

C. Project work

ICT in Accounting teachers are encouraged to sample and prepare project works and engage their students in as many as possible. Students in groups or individually are engaged in a self-directed work for an extended period of time to investigate and respond to a complex question, problem, or challenge. The work can be presented to classmates or other people beyond the school. Projects are based on real-world problems that capture the students' interest. This technique develops higher order thinking as the students acquire and apply new knowledge in a problem-solving context.

D. Field trip

One of the main aims of teaching ICT in Accounting in Rwanda is to apply its knowledge for development. To achieve this aim we need to show to students the relationship between classroom science lessons and applied sciences. This helps them see the link between science principles and technological applications.

To be successful, the field visit should be well prepared and well exploited after the visit:

Before the visit, the teacher and student:

- Agree on aims and objectives
- Gather relevant information prior to visit
- Brainstorm on key questions and share responsibilities
- Discuss materials needed and other logistical and administrative issues
- Discuss and agree on accepted behaviors during the visit
- Visit the area before the trip if possible to familiarize yourself with the place

After the visit

When students come back from trip, the teacher should plan for follow-up. The follow-up should allow students to share experiences and relate them to the prior science knowledge. This can be done in several ways; either: Students write a report individually or in groups and give to the teacher for marking. The teacher then arranges for discussion to explain possible misconceptions and fill gaps. Or students write reports in groups and display them on the class notice board for everyone to read.

Main steps for a lesson in active learning approach

All the principles and characteristics of the active learning process highlighted above are reflected in steps of a lesson as displayed below. Generally, the lesson is divided into three main parts whereby each one is divided into smaller steps to make sure that students are involved in the learning process. Below are those main parts and their small steps:

1) Introduction

Introduction is a part where the teacher makes connection between the current and previous lesson through appropriate technique. The teacher opens short discussions to encourage students to think about the previous learning experience and connect it with the current instructional objective. The teacher reviews the prior knowledge, skills and attitudes which have a link with the new concepts to create good foundation and logical sequencings.

2) Development of the new lesson

The development of a lesson that introduces a new concept will go through the following small steps: discovery activities, presentation of students' findings, exploitation, synthesis/summary and exercises/application activities, explained below:

Discovery activity

Step 1

- The teacher discusses convincingly with students to take responsibility of their learning
- He/she distributes the task/activity and gives instructions related to the tasks (working in groups, pairs, or individual to instigate collaborative learning, to discover knowledge to be learned)

Step 2

- The teacher let the students work collaboratively on the task.
- During this period the teacher refrains to intervene directly on the knowledge
- He/she then monitors how the students are progressing towards the knowledge to be learned and boost those who are still behind (but without communicating to them the knowledge).

Presentation of students' productions

- In this episode, the teacher invites representatives of groups to present the students' productions/findings.
- After three/four or an acceptable number of presentations, the teacher decides to engage the class into exploitation of the students' productions.

Exploitation of student's productions

- The teacher asks the students to evaluate the productions: which ones are correct, incomplete or false
- Then the teacher judges the logic of the students' products, corrects those which are false, completes those which are incomplete, and confirms those which are correct.

Institutionalization (summary/conclusion/ and examples)

 The teacher summarizes the learned knowledge and gives examples which illustrate the learned content.

Exercises/Application activities

- Exercises of applying processes and products/objects related to learned unit/sub-unit
- Exercises in real life contexts
- Teacher guides students to make the connection of what they learnt to real life situations. At this level, the role of the teacher is to monitor the fixation of process and product/object being learned.

3) Assessment

In this step the teacher asks some questions to assess achievement of

instructional objective. During assessment activity, students work individually on the task/activity. The teacher avoids intervening directly. In fact, results from this assessment inform the teacher on next steps for the whole class and individuals. In some cases, the teacher can end with a homework assignment.

UNIT COMPUTER SECURITY

1.1 Key unit competence

Identify various computer security threats and prevents them

1.2. Prerequisite knowledge and skills:

Students are already familiar with windows explorer, compute software and hardware, they will then find it easy to apply computer security and take measures for protecting computers against any kind of virus.

Students have also dim understanding of what a database is as they use a computer external storages such as flash disk, external hard disk, SD memory cards, and visit different online application which are the main root/sources of different types of viruses.

1.3. Cross-cutting issues to be addressed:

Throughout every lesson, cross cutting issues have to be addressed. Addressing cross cutting issues makes a lesson not a standalone entity but something that is related to real issues in society. Here are how cross cutting issues are addressed:

- Standardization culture: While learning Computer security, students become aware antiviruses program installation requires a certain level of standardization for a proper selection of an antivirus to be used.
- Financial Education: Is covered when students discuss the cost implication invested in buying antivirus security keys and the financial benefits of installing an antivirus.
- Gender education: students must be aware that ICT is not a subject appropriate only for girls or boys. ICT topics especially those related to computer security are appropriate for both sexes not for only boys.

1.4. Guidance on the introductory activity

- The teacher organizes students in pairs in order to do the unit's introductory activity.
- The teacher asks students to do the introductory activity in their respective groups.
- The teacher moves around to see how students are working and provides guidance where it is needed.
- The teacher invites some groups to presents their findings to the class
- The teacher asks students to evaluate the findings.
- The teacher tells students that in the coming lessons they will have complete answers.

Answer of introductory activity

i) Jane's computer has been attacked by viruses, because a virus disturbs the normal performance of the computer by damaging operating system files and other data stored in the computer.

- With the guidance of the teacher the class discuss the different cause of

slowing down the computer and loss of some data from the hard disk.

- As students have now got answers, they evaluate their findings that they
 presented at the beginning of the lesson
- The teacher gives guidance on how to do the application activity 1.3





- e) **AutoShapes:** AutoShapes toolbar will allow us to draw some geometrical shapes, arrows, flowchart items, stars, and more. With these shapes, we can draw our graphs.
- f) Wizard: It guides us to work effectively while we work by displaying several helpful tips and techniques based on what we are doing. Drag and Drop feature will help us to reposition the record and text by simply dragging the data with the help of the mouse.
- g) **Charts:** This feature will help you to present the data in graphical form by using Pie, Bar, Line charts, and more.



Content of the presentation:

- Use the slide master feature to create a consistent and simple design template. It is fine to vary the content presentation (bulleted list, two-column text, text and image, etc.), but be consistent with other elements such as font, colors and background.
- Simplify and limit the number of words on each screen. Use key phrases and include only essential information.
- Limit punctuation and avoid putting words in all-capital letters. Empty space on the slide will enhance readability.
- Use contrasting colors for text and background. Light text on a dark background is best. Patterned backgrounds can reduce readability.
- Avoid the use of flashy transitions such as text fly-ins. These features may seem impressive at first but are distracting and get old quickly.
- Overuse of special effects such as animation and sounds may make the presentation "cutesy" and could negatively affect the credibility.
- Use good-quality images that reinforce and complement the message.
 Ensure that the image maintains its impact and resolution when projected on a larger screen.
- Limit the number of slides. Presenters who constantly "flip" to the next slide are likely to lose their audience. A good rule of thumb is one slide per minute.
- Learn to navigate the presentation in a nonlinear fashion. PowerPoint allows the presenter to jump ahead or back without having to page through all the interim slides.
- Know how to and practice moving forward and backward within the presentation. Audiences often ask to see a previous screen again.
- If possible, view the slides on the screen that will be using for the presentation.
 Make sure the slides are readable from the back row seats. Text and

graphic images should be large enough to read but not so large as to appear "loud."

- Have a Plan B in the event of technical difficulties Remember that transparencies and handouts will not show animation or other special effects.
- Practice with someone who has never seen the presentation. Ask them for honest feedback about colors, content and any effects or graphic images that are you've included.
- Do not read from the slides. The content of slides is for the audience, not for the presenter.
- Do not speak to slides. Many presenters face their presentation onscreen rather than their audience.
- Do not apologize for anything in presentation. If something could will be hard to read or understand, don't use it.

Answer 2: Definitions

Presentation software is a program used to create slide shows for presentation on screen to an audience. Presentation program/software can supplement or at times can replace use of visual aids like handouts, chalkboards, posters, etc.

Microsoft PowerPoint: is a presentation software that allows you to create dynamic slide presentations. Slideshows can include animation, narration, images, videos, and much more.

A slide is a single page of information in a presentation created with a program such as PowerPoint. A presentation is composed of several slides.

UNIT 5

DATABASE MANAGEMENT WITH ACCESS

5.1. Key unit competence:

Create and manipulate a simple database.

5.2. Prerequisite knowledge and skills:

Students are already familiar with office programs, their menu and their tools and how to use them, they will then find it easy to use the different menu and tools found on Microsoft Office Access.

Students have also dim understanding of what a database is as they visit different websites having an underlying database. They are aware of the managements of records at their schools which can help them easily understand the database concept.

5.3. Cross-cutting issues to be addressed:

Throughout every lesson, cross cutting issues have to be addressed. Addressing cross cutting issues makes a lesson not a standalone entity but something that is related to real issues in society. Here are how cross cutting issues are addressed:

- Standardization culture: While learning Access, students become aware that data from programs like Excel can be imported into Access like data from Access can be exported in Excel. This requires that there be a certain level of standardization which allows that each program can read content from the other.
- **Financial Education:** Is covered when students discuss the cost implication involved in designing a new database and the financial benefits of having a database system.
- **Gender education:** students must be aware that ICT is not a subject appropriate only for girls or boys. ICT topics especially those related to database design are appropriate for both sexes not for only boys.

5.4. Guidance on the introductory activity

- The teacher organizes students in groups of four in order to do the unit's introductory activity.
- The teacher asks students to do the introductory activity in their respective groups.
- The teacher moves around to see how students are working and provides guidance where it is needed.
- The teacher invites some groups to presents their findings to the class
- The teacher asks students to evaluate the findings.
- The teacher tells students that in the coming lessons they will have complete answers.

LESSON 1: Understanding database

a) Learning objectives

Explain the benefits of using a data management system over Traditional File Processing System

b) Teaching resources:

For this lesson to be effective students and students will need to have student books and computers with internet connectivity for doing research in order to understand different database concepts.

c) Prerequisites

Students already learnt Word, Excel and PowerPoint and are therefore familiar of how information is kept by using those Word, Excel and PowerPoint files and this can help them understand the database concepts. They also encountered different applications which have databases and this may help grasp the meaning easily.

d) Learning activity:

Guidance:

- This is the beginning of the whole unit on Database creation and manipulation.
 This lesson is preceded by an analysis of the introductory activity which is given as a homework then discussed as the new unit starts
- The lesson on "Understanding database" starts by giving answers to the question in the activity 5.1
- Under the guidance of the teacher, students explore how database approach came in place, what was the disadvantages of the old approach and the advantage of the new one.
- The teacher gives guidance on how to do the questions in the application activity 5.1
- The meaning of the term database can be got from the student's book.
 Students then give examples of databases that are used in their school environment or society.

Answers of activity 5.1

The meaning of the term database can be got from the student's book. Students then give examples of databases that are used in their school environment or society.

e) Application activity 5.1

Answers: Students may answer question 1, 2 and 3 basing on the knowledge they have got from this lesson or simply by reading the content of the student's book in the corresponding section or through doing further research.

LESSON 2: Key terms used in Database

a) Learning objectives

Explain the different terms related to database management

b) Teaching resources

For the effectiveness of the lesson, it is necessary to have student's book and computers with internet connectivity to facilitate research which is very necessary for understanding the database key terms

c) Prerequisites

Students have some understanding on database got from the first lesson of this unit and can apply it in learning easily this lesson.

d) Learning activity:

Guidance:

- The lesson starts with a quick presentation by students who have done a research as instructed by the activity 5.2
- Under the guidance of the teacher, students explain the different terms found in the database world
- The teacher displays an access tables and students identify its different parts (rows, columns) and their other nominations

Answers of activity 5.2

Explanation of the terms research can be got in the student book. Students do research to find advanced explanations. They also find other terms and explain them. Some of these terms can be found in the student's book in the section on "Key terms used in database".

e) Application Activity 5.2

Answers: Answers for the questions 1, 2, 3, 4 and 5 for this section 5.2 are found in the student book. For answers that cannot be immediately found the teacher help students refine the answers or search for them on the internet.

LESSON 3: Database design process

a) Learning objectives

Explain the process for designing a database

b) Teaching resources:

Resources needed for this lesson are: student's book and computers with internet connectivity for doing additional research.

c) Prerequisites

Students are used to delivering lessons in primary classes, they know what it requires them from to have a lesson ready for delivery; they can therefore apply this reasoning in this new lesson.

d) Activity:

Guidance:

- Start the lesson by making group of 2students
- In groups, students start doing the activity 5.3
- In groups students discuss the scenario in activity 5.3, present their findings and the whole class discuss on the findings.
- With the guidance of the teacher the class discuss the steps for database design and brainstorm what is done in each step
- As students have now seen the steps of database design they evaluate their findings that they presented at the beginning of the lesson
- The teacher gives guidance on how to do the application activity 5.3

Answers of activity 5.3

- 1. Students discuss the different steps to go through in order to solve the problem presented in the scenario. This was done at the beginning of the lesson but as the lesson ends and they have more knowledge they try to improve what they had found. Steps to go through in designing a database are available in student book.
- 2. A computerized data base for school library management will facilitate all system users, for the students it will be very easy to be served without taking much time as student were supposed to go and search the needed book, for the librarian, it will be easy to keep all information related with the books in the library, borrowed books, returned book and provide reports in an easy way, for the school management it will be easy to access easily all information regarding the library.

e) Application Activity 5.3

Answers: The questions of activity 5.3 can be answered by reading the content available in the student book.

LESSON 4: Creating, saving, closing and opening a database

a) Learning objectives

Manipulate a database by creating, saving, opening and closing it

b) Teaching resources

This lesson will require the existence of these materials: one computer for each student in the computer laboratory with Microsoft Office 2019 installed, projector for demonstrating examples, student book and internet connectivity for doing researches.

c) Prerequisites

Students already know how to open, save, and close Word, Excel and PowerPoint documents as they learned the related units in Ordinary level. As this is much the same in Access, they will find it easy to apply the same in this new lesson.

d) Activity: 4.5

Guidance:

- Under the guidance of the teacher, individually, students read and answer questions in the activity 5.4
- The teacher opens Access 2019 and try to show the different objects in it and explains their roles in an Access database
- The teacher demonstrates how to create a database in Design, how to open and close a database and students follow suit.

Answers of activity 5.4

- 1. Using MS Access 2019, students create and name respectively: Foods StockIn and StockOut tables.
- 2. Each Students identifies a primary key for each table
- 3. Student discusses the importance of the primary key in each table. (all additional information is provided in student book)

e) Application Activity 5.4

Answers:

Using the steps of database creation as they have seen them in the lesson, students create an Access database and save it on the desktop

In the created database "Payroll", students create two tables for "STAFF marks for and SALARY. Indicate the right primary key and define the right data type.

LESSON 5: Creation of table relationship

a) Learning objectives

Establish database table relationship

b) Teaching resources:

Teacher and students will need computers in the computer lab with Office 2019 installed, projector for demonstrating examples to the class, student's book and internet connectivity for doing more research.

c) Prerequisites

Students have seen tables in Word and Excel. They know that tables may be related by having columns that are much alike or completely the same. This may be built on in making them understand relationships in Access and why it is necessary.

d) Learning activity:

Guidance:


- This lesson is started by grouping students and making them search for the importance of establishing relationships in database tables.
- For each kind of table relationship, the teacher narrates a story on which he/ she then ask questions in order to make students discover it
- By questions and answers, students give characteristics of each table relationship
- The teacher gives guidance on how to do application activity 5.5 in which students are going to create relationship of the tables.

Answers of activity 5.5

A relationship, in the context of databases, is a situation that exists between two relational database tables when one table has a foreign key that references the primary key of the other table.

Relationships allow relational databases to split and store data in different tables, while linking disparate data items. For the rest of the answers to an activity can be found in the student's book, section 5.5.

e) Application Activity 5.5



LESSON 6: Adding Data to a database (data entry)

a) Learning objectives

Enter data in an Access database table in data sheet view or using created forms

b) Teaching resources:

Students will need computers in the computer lab with Office 2019 installed, projector for demonstrating examples to the class, student's book and internet connectivity for doing more research. There will also be a need of data on hard copy or excel data to be imported in Access.

c) Prerequisites

Students are familiar with entering data in other programs like word tables and Excel. They can apply their skills in entering data in an Access database.

d) Learning activity:

Guidance:

- The lesson starts with students doing the activity 5.6
- With the guidance of the teacher, students explain the terms like front end and backend
- Under the guidance of the teacher, students open the library database in datasheet view and enter data from a hard copy
- Under the guidance of the teacher, students create forms that they are going to use in entering data in the library database
- The teacher shows how to design a beautiful form for a database with logo, an interface for a database application
- The teacher gives guidance on how to do application activity 5.6

Answers of activity 5.6

- 1.Data entry is the process of inputting data or information into the computer using devices such as a keyboard, scanner, disk, and voice.
- 2. Answers for this question are available in student book.
- 3. The front-end refers to the user interface, while "back-end" means the server, application and database that work behind the scenes to deliver information to the user.

Application activity 5.6:

1.Students create a student registration form. All steps to create such form are available in student book.

LESSON 7: Querying a database in design view

a) Learning objectives

Create queries in design view to respond to data requests

b) Teaching resources:

For this lesson these materials will be needed: Computers with Microsoft Office 2019 installed, student book, projector and internet connectivity for conducting research

- Computers in the computer lab with Microsoft Office 2019 installed
- Senior 6 student's book
- Internet connectivity for researching how queries are designed
- Projector for demonstrations to students

c) Prerequisites

Students are familiar with searching for specific data in Excel by filtering, they can then apply it in querying an Access database.

d) Learning activity:

Guidance:

- Students brainstorm the meaning of queries and the role they play in a database
- Under the guidance of the teacher, students recall the tables that compose the school library database, the columns in those tables, the data types, the primary and foreign keys.
- The teacher demonstrates the steps to follow in order to build a query in design view
- The teacher creates a design view query to run on one table, students follow suit
- The teacher gives quick exercises of queries involving one table and students create and run those queries
- The teacher presents to students the scenario where they want to get data that can be got from more than one table and asks questions on how to get

the result

- The teacher demonstrates how to create and run queries involving many tables
- Quick exercises to create queries on many tables are given and students create queries and run them
- As students do exercises the teacher moves in the class to help those that may be having difficulties
- The teacher gives guidance on how to do application activity

Answers of activity 5.7

1. students create the table which can keep the given data using MS Access, students display all customers and their corresponding accounts numbers

e) Application Activity 5.7

The questions of activity 5.7 can be answered by reading the content available in the student book.

5.6 Additional information

For teaching the unit "Database Creation and Manipulation" Microsoft Office Access 2019 is used. This goes in line with other office programs which are taught from Year One to Year Two. It is not advised to use advanced office program and is forbidden to use older versions than Office 2019. When this is done, the accompanying student book will be of less help

Since learners are already familiar with computers and learnt Office programs from Senior One, it was not necessary to give all the details. For example, it was judged not necessary to explain how to copy and paste text, how to write using the keyboard, etc.

Most, if not all the lessons in this unit are taught using a computer and a projector so that the teacher demonstrates to students' examples that they will follow in going exercises.

5.7. Skills lab 4

For this skills lab, students will be able to Create and manage a database for a business

Guidance to the lab:

This skills lab will be done in class. Different groups will choose different projects (businesses) for which they will create databases. They may also choose other businesses in their environment and in this case some phases of building this database will be done outside the class.

i) Build

- With questions and answers, students understand what they are going to do.
 They have to understand the importance of a database for a business and the solutions that will be brought by that particular database
- By the guidance of the teacher, students review the database design process
- Students divide themselves in groups and identify database projects on which they will work

ii) Practice

- Students design a questionnaire that they will use to gather information on the business process of the institution (or company, or business) for which they want to build a database
- Using the information gathered Students identify the different tables that will constitute the database. Students build an entity relationship diagram showing table names, their fields, their primary keys and foreign keys
- Students build the database using computers. They make forms that will be used to enter data
- Students make any additional interface that will help the database users interact with that database and produce different reports.

iii) Presentation

- When students finish their database projects they present them to the class.
 The teacher may invite other teachers to appreciate the different projects and provide incentives to those with best projects
- While presenting, make sure students show how their database is built, the primary and foreign keys, the data validation applied on the tables. Students should also explain how they came up with their projects

iv)Conclusion

Let students summarize the database creation process and explain what is the importance of a computerized database for a business.

5.9 Additional activities

5.9.1 Remedial Activity

- 1. Define the following terms:

Answer: A database is an organized collection of related data so that its contents can easily be accessed, managed, and updated. It is considered to be organized because the data is stored in categories that are accessible in a logical manner.

Data

Answer: Data are unprocessed raw facts that include text, number, images, audio, and video. The data are useless for decision-makers until they have been processed or refined in some manner.

information

Answer: Information is data that has been processed, refined and then given in the format that is suitable for decision making or other organizational activities.

2. Give the disadvantages of using Traditional File Processing System

Answer

- Separation and isolation of data: as data is isolated in many files, it is not easy to have access to data.
- Duplication of Data: because of the decentralized management, data may be scattered on different computers and this has as consequences a misuse of storage space as data is repeatedly stored in different locations (This is known as Data Redundancy) and a loss of data integrity as data is stored in different locations and the different copies may be slightly different.
- Wastage of storage space: Duplication of data leads to wastage of storage space. If the storage space is wasted it will have a direct impact on cost. The cost will increase.
- Loss of data integrity: Data integrity means data consistency. Duplication
 of data can also lead to loss of data integrity; the data are no longer
 consistent.

• Data dependence: in traditional file processing, the structure of data files is embedded in the application programs, so any changes to the structure of a file may require changing all programs that access this file. Therefore, data dependence means the application program depends on the data. This means that if some modifications have to be made on data, then the application program has to be rewritten.

 from the other.
- Financial Education: Is covered when students discuss the cost implication involved in designing a new database and the financial benefits of having a database system.

Lesson 1: Emails

a) Learning objective

Create Gmail accounts using internet browsers

b) Teaching resources

For this lesson to be well conduct, the following resources need to be available:

- Computers with internet connectivity to allow email accounts creation
- Textbooks with the content about email creation
- Projector to show to students the process to create an email
- The student book or any other textbooks on emails

c) Prerequisites

Students have been learning ICT from Senior One. They are therefore familiar with Office programs and have basic skills on yahoo emails learned in Senior One. These skills will facilitate the learning of this new lesson. Students also know how to enter a URL address in a browser's address bar and the transfer of this knowledge will help in accessing the Gmail URL.

d) Learning activities

Guidance

- The teacher introduces the lesson by asking question related to the traditional post office by focusing on its disadvantages
- Students brainstorm how the disadvantage of the post office can be solved and state which communication means helped solve them
- Students play the place of business owners and state how emails can help them improve their business. Example: How a hotel owner can have his business prosper by using emails?
- With questions and answers students explore the content of the lesson. They will come to explain the terms like email and understand the email format
- Using a projector and with the active participation of learners students explore how to create a Gmail account.

Answers to activity 6.1

- 1) Generally sending and receiving mails at post offices operate this way:
 - The mail sender puts his/her mail in an envelope and writes the recipient's address on it. The mail sender pays for mail sending price and a stamp is put in the envelope
 - The mail envelope is put in the mail collector.
 - In the mail collector, the mail envelopes are sorted depending on their destination
 - Mail envelopes are then transported to their destination by air, sea, car depending on how far is the destination
 - At the destination the envelope is dropped to the box of the receiver
 - The receiver opens her/his box, takes the mail envelope.
- 2) a. A person can send and receive an email using a computer by first opening an email service provider (examples: gmail.com, yahoo.com) program whose URL address is entered in the browser's address bar. In the window that will appear, the email sender will specify his/her email and password to login. The email sender will click on **Compose**, then specify the receiver's address and the addresses to receive copies. He/she will then write the email, upload the attachment (if any) and click on the **SEND** button

- b. Two examples of email service providers are: Outlook, yahoo
 - 3) Answers on how emails may improve the works are varied but they should include the following: Emails will facilitate delivery of emails as they are fast and can be sent any time anywhere. They can also be sent to many people at the same time. All this will save time and resources.

e) Answers to application activity 6.1

Lesson 2: Sending and receiving email

a) Learning objective

Send, receive emails and their attachments using Gmail accounts

b) Teaching resources

Teachers or students will need these resources for a better course of the lesson:

- Image of someone sending an email using a computer and another posting a letter at the post office. These images will be used to introduce the lesson.
- Computer with internet connectivity which will be used to create emails

- Wall charts if available. These wall charts will show the different parts of a Gmail window environment
- Projector to help in displaying the steps to all students
- The student book or any other textbooks on using emails

c) Prerequisites and introduction

- Students know how to create emails and this will facilitate learning this new lesson
- The lesson will be introduced basing on the previous lesson (Email)

d) Learning activities

Guidance

- The teacher will show images of two people, one sending email using a computer and another putting a letter in the box at the post office. If no images are available, the teacher will just ask questions aimed at making learners discover the two methods of sending and receiving mails.
- The teacher shows a chart showing the different parts of a Gmail window environment showing the different parts which are also in the student book in the section "6.2. Sending and receiving email"
- With questions, the teacher will make students discover the procedure to go through in order to have access to the email. What student state is done on their computers and on the teacher's computer which is connected to a projector for displaying the screens
- Students practice sending and receiving emails. By questions and answers students summarize the steps of sending and receiving emails.
- Student send each other emails with or without attachments.
- For all this procedure, the teacher checks if every student is not left behind and helps those that may be facing difficulties

Answers to activity 6.2

The method being used in image B is: Post Office

2) The email method is more efficient as it is more flexible meaning that an email can be sent anywhere, anytime and is promptly received. This method is also less expensive.

b) Teaching resources

For this lesson to be carried out efficiently students or the teacher will need the following resources:

- Computers with internet connectivity to facilitate using search engines
- Projector to allow the displaying of the teacher's demonstrations
- The student book or any other textbooks on search engines

c) Prerequisites/Revision/Introduction

- Students know how to use web browsers and how to enter a URL in the address bar when they want to visit a website
- Students know how to write grammatically correct sentences. This skill will be used the search topic in the search engine

d) Learning activities

Guidance

- The teacher ask students to give examples of most used websites around the world. Among the ones given by students the teacher writes on the blackboard those that are search engines
- Under the guidance of the teacher, students visit one of the search engines they have given (google.com) and write the keyword Accounting. They get a screen looking like the one in Activity 6.3
- Referring to the screen they get, they answer the question of activity 6.3
- The teacher makes learners discover the lesson title by referring to the activity 6.3 they have done. If they don't find the right topic the teacher helps them.

Thereafter the lesson is conducted through questions and answers. For each search technic, students brainstorm the search results and analyze their accuracy.

Answers to activity 6

- 1)The student entered this topic: Accounting
- 2) The student doing the research found mixed content and did not find the information about balance sheet as he/she expected. The reason for not finding information about balance sheet is because the topic entered is too broad. The topic should be narrowed down to Balance Sheet or further narrowed down to get a few content which is much related to what the student wants.
- 3)After writing the topic Balance Sheet in Finance the student gets more accurate results because the topic is now more precise.
- 4) When the topic "Balance Sheet in Finance" is written inside quotation marks the results becomes more accurate.

c) Prerequisites

Students learned the purchase and sale process in different Accounting lesson. Now they are going to carry out this process using online means.

d) Learning activities

Guidance

 This lesson will be conducted mostly in a role play. One group of students will play the role of business owners and the other group will act as clients.

- Recall the steps of a sale and purchase process
- Under the guidance of the teacher students play the role of clients and business owners. They communicate among them using Emails to carry out each step.

Answers to activity 6.4

Students will explain how the concepts inquiry and quotation are applied in an online sales and purchase process. They use their own terms and it is not a problem if their answers are not perfect because this is a topic they have not yet learnt.

- Students have already seen the lesson on Online Business Communication.
 The competences acquired in this lesson can be transferred to this new lesson
- Students have basic knowledge on ecommerce as they saw it in S2 in the section "2.2.1 E-Commerce"

c) Learning activities

Guidance

- The teacher introduces the lesson by making students do the activity 6.5. At

the end of this activity students, under the guidance of the teacher discover the lesson title

- By the help of questions and answers, students discover what is E-commerce and the meaning of the different E-commerce concepts
- Under the guidance of the teacher, learners visit some ecommerce platforms and discover their main features.

Answers to activity 6.5

b) Teaching resources

For this lesson to be conducted efficiently, the following resources are needed:

- Textbooks for Senior 4 or any other textbooks which may contain content related to E-procurement, E-tax and E-payment
- Computers with internet connectivity to facilitate research and access to some platforms which provide services related to e-procurement, e-tax and e-payment
- Projector to allow the displaying of screens for different e-procurement, e-tax and e-payment platforms

c) Prerequisites

- Students are familiar with using the internet and accessing different websites.
 They will find it easy to visit different e-procurement, e-tax and E-payment platforms
- Students are familiar with the terms procurement, tax and payment as they learned them in accounting related subjects

d) Learning activities

Guidance

- The lesson is introduced by doing the activity 6.6. The teacher guides learners in this activity.
- Under the guidance of the teacher, learners visit some e-procurement,
 e-tax and e-payment platforms and discover their main features.

Answers to activity 6.6

- 1)Students do a research and find out how procurement, tax collection and fee payment was done in Rwanda in the years 1980. They discover that there was no computerized system to manage that. Therefor there are disadvantages related to doing things manually.
- 2) Nowadays procurement, collection of taxes and fee payment is done using computerized systems. Briefly students explain how this is done.

e) Answers to application activity 6.6

- 1) Students enumerate the features found in the E-procurement system (umucyo.gov.rw).
- 2) Students describe one can do using e-tax application (RRA application) and its advantages.
- 3) Students give examples of services paid using E-payment methods and which and which types of payments allowed for each service.

6.6.Additional information for teachers

For a teacher to effectively deliver the lessons in the unit "Online Business Correspondence" he/she needs to do an extensive search both on the internet or hard copy textbooks where they are available. Students have basic knowledge of some lessons as they learned basic content in lower secondary. Those lessons for which learners have prerequisites are: Emails, Sending and Receiving emails and search engines. For these lessons the teacher will conduct the lesson taking into account of the students' prerequisites. Some other lessons are linked to other Accounting subjects like online purchase and sale process. For these lessons you may make sure that student remember the related concepts in the other subjects but without taking a lot of time.

Without contrasting the methodological guidance provided for each lesson, the teacher will try to start the lessons by making students do the questions in the corresponding activity. In this way learners will discover the new lesson.

6.7. End unit assessment



New HTML5 Elements

The new HTML5 elements may be classified into three categories namely: Structural, Input, and Media elements.

Structural elements: HTML5 offers new semantic elements used to define the structure of a web

page. Examples of structural elements include <article>, <aside>, <header>, <footer>, <main>, <section>, <summary> and <nav>

Input elements: New input types were introduced to address specific form input and formatting requirements for user input such as dates, numbers, and telephone numbers. Examples of new input types include color, date, datetime, time, email, number, tel, url

Media elements: Due to high demand of multimedia content on the web, WC3 introduced new set of media elements in HTML5 to handle different media types without need for additional plugins such as Adobe flash. New media elements include <embed>, <audio>, <source>, <track> and <video>.

Colors

One of the most important formatting features in web design and development has to do with the right application of color. Color can be applied to text (font) or the background of a section or entire page.

In HTML, color can be specified in either of three ways:

- 1. Using a valid color name as a value in a declaration e.g. "red", "blue"
- 2. Using a valid hexadecimal (HEX) value e.g. #ff1100, #BB00CC
- 3. Using the Red, Green, Blue (RGB) scheme e.g. "rgb(200,1,1)"



Today, large corporations, medium-sized, small -scale business, organizations and individuals are using websites and web applications to communicate company information, manage their projects and advertise their activities. People are now connected with their friends and family members on social media such as Facebook, Twitter, Instagram, YouTube and these social media technologies were developed using web design techniques. In this unit, we discussed HTML language used in designing website and web applications.

Below are the main concepts discussed in this unit:

A **website** is a collection of several web pages with information on a subject (documents that are accessed through the internet) that are connected together.

A **Web application (Web app)** is an application program that is stored on a remote server and delivered over the Internet through a browser interface.

A website can be static or dynamic. In this unit, we only discussed about the on static website. A static web site is site that is typically written in plain HTML and what is in the code of the page is what is displayed to the user and it does not use database. A dynamic webpage is one whose contents do change, and generally change very quickly and it uses database.

A static web page is made of different web pages. HTML page has the following structure:

There different HTML tags that create different web pages:

- Tags that identify and name documents such as heading tags, image, formatting tags etc.
- Tags that organize web page contents such as:
- Ordered and Unordered list:and

- nested lists: a list inside another type of a list
- Frame and Table tags :<frameset> and
- HTML Forms: <form>

Nowadays, HTML5 is more useful comparing to other previous HTML versions because of its specifications:

- It offers new features that support multimedia contents
- It is designed to be supported by majority of browsers
- It comes with elements (media elements and new input types)

HTML pages are linked by **hyperlinks** for being called website .HTML link is created by anchor element<a>.... It has this syntax: **link** text

The website creation project involves these steps:

The exact process will vary slightly from designer to designer, but the basics are the same.

- The **front end** is the part of the website, users can see and interact with. It is developed using Visual Basic, HTML, etc programming languages
- The back end can also be referred to as the "server side" of a website.
 It can be built using different Relational Database Management Systems such as Microsoft Access, SQL Server, Oracle etc.

Advantages of a static web page and dynamic web page

Advantages of a static website

- Saves Time: Development of static websites saves time, because static websites are easy to develop.
- Money saving approach: Static websites are money saving, because such websites are cheaper to develop as compared to dynamic websites.
- Hosting: Static websites are easier to host, because static websites have fixed data.
- Indexing: Search engines such as Google, Bing etc., can easily index a static website.
- Fast Transfer: Static websites can be quickly transferred from server to client without much processing time.

Advantages of a Dynamic Website

- Simple to update: Dynamic websites are simpler to update. You don't need expert knowledge to make changes to a dynamic website.
- User-focused design: Dynamic websites are built by keeping users in minds.
 Users can make preferred changes to such websites.
- Highly responsive: Dynamic websites can be quickly updated to become responsive to different screen sizes.
- **Highly functional:** Dynamic websites are highly functional. Users can make many changes to dynamic websites.
- SEO (Search Engine Optimization) friendly Design: Dynamic websites are SEO-friendly.

A **Web application** (**Web app**) is an application program that is stored on a remote server and delivered over the internet through a browser interface. A

web application is a software or program which is accessible using any **web** browser.

Advantages of web Applications

Web applications are more popular because of the following reasons:

- Compared to desktop applications, web applications are easier to maintain as they use the same code in the entire applications.
- Web applications can be used on any platform: Windows, Linux, Mac as they all support modern browsers
- Released any time and in any form. No need to remind users to update their applications.
- They can be accessed 24 hours of the day and 365 days the year from any computer.
- A computer or a mobile device can be used to access the required data.

Disadvantages of web Applications

- Security is not guaranteed, so it is vulnerable for unauthorized access
- The web app may not support multiple browsers with equal precedence
- The web application is built explicitly for a certain operating system, so it is difficult to discover from the app store.
- Limited scope to access the device's features.

Conclusion

There is no involvement of application program in the static web page whereas dynamic web page involves an application program which can perform the various operations. Although, static and dynamic web pages have to return HTML contents to the web browser with the use of HTTP protocol, in order to interpret and display them on the browser.

A. Advantages of static websites

- **Faster speed:** Being a static file when a user visits a page, all the web server has to do is return a file. No server-side code is executed. Differently with dynamic websites there is extra processing time required to deliver HTML pages.
- More secure: Since there is no back-end server-side processing, there
 is less surface area for attacks and there is no database available to be
 compromised.
- Lower cost: As they don't have a database, static websites require less maintenance and are cheap to host.
- **Easier to scale:** When a website is hosted on the Cloud it is ready to be scaled at any time. Although similar techniques can be applied with dynamic websites, it will be more complex as database scaling might be required.
- Backups/Full editorial history: It is possible to see who changed which content and when if version control tools such as GIT are used.

B. Advantages of dynamic websites

- **Easier to update content:** Using a CMS (Content Management System) web interface for managing content will allow to make changes easily.
- More flexible: When creating a dynamic website, the programmer has full control of the wheel to create whatever interactive feature needed

Content

Even if your webpage is easily accessible, functions well, works quickly, and looks great, they still won't be pleased unless you have compelling and engaging content on your site. Content marketing plays a major role in any company's advertising campaign. People much prefer video content over written, which is why content video views have exceeded 50 billion views per month.

- a. **GIF** (Graphics Interchange Format): You can take advantage of the characteristics of lzw compression to improve its efficiency and thereby reduce the size of your gif graphics. The gif format allows you to pick colors from the color lookup table of the gif to be transparent.
- b. **JPEG** (Joint Photographic Experts Group): The other graphic file format commonly used on the web to minimize graphics file sizes is the Joint Photographic Experts Group (jpeg) compression scheme. Unlike gif graphics, jpeg images are full-color images that dedicate at least 24 bits of memory to each pixel, resulting in images that can incorporate 16.8 million colors.

8.3. Cross-cutting issues to be addressed:

As you conduct lessons, take into account different crosscutting issues to be addressed throughout the lessons. When crosscutting issues are addresses, a lesson is no longer a standalone entity but is now something which is related to real issues in society. Here are how cross cutting issues are addressed:

- **Environment and sustainability:** Students have to be aware that there are different ways of disposing off old ICT tools. They will then use those methods when it comes to disposing off their own old ICT tools.
- Standardization culture: While learning different lessons, students become aware that there most ICT tools have same parts like input, output and processing parts. They realize also that most tools have same ports so that they may interconnect to work together. This requires a certain level of standardization which allows that those tools can work together.
- **Financial Education:** Is covered when students discuss the benefits of using the ICT tools stated in the lesson or the unit compared to when those tools are not used.

 Gender education: Students must be aware that ICT in Accounting is not a subject appropriate only for girls or boys. ICT in Accounting topics especially those related to ICT tools are appropriate for both sexes not for only boys.

8.4Guidance on introductory activity

- Students silently read the questions in the introductory activity and analyze
 it. After this the teacher chooses one student who then read for the whole
 class.
- Under the guidance of the teacher, students answer the questions in the introductory activity. As students give answers the teacher makes sure they are right ones and if not those answers are complemented by other students or by the teacher
- Under the guidance of the teachers students brainstorm the importance of ICT tools in acounting

Lesson 1: Counting machines

a) Learning objectives

- Explain the working of counting machines
- Explain the role of the different parts of a counting machine

b) Teaching resources

For this lesson to be effective, the following resources are needed:

- Charts or images of counting machines or real counting machines if they can be available
- The student book for Senior 4 or any other textbooks with the content about conting machines
- Computers with internet connectivity to facilitate research on counting machines.

c) Introduction

The introduction of the lesson is done using the questions in the activity 8.1. However some of the questions (question 2 and 3) cannot be answered. The teacher replace them with those that students can answer which will lead them to discovering the lesson title

d) Learning activities

Guidance

- The teacher introduces the lesson by making students do the activity 8.1. At the end of this activity students, under the guidance of the teacher discover the lesson title
- By questions and answers, students discover that there are different types of counters.
- Guided by the teacher, students discover the different types of counters, their parts and their roles
- If possible the teacher brings a counting machine and demonstrates how it works

Answers to activity 8.1

- 1)The tools to be used in money counting are counting machines such as banknotes only counters,
- 2)The students explain how to use a counting machine, this information can be found in the student book in the section "71.Counting machines"
- 3)The parts of a counting machine are detailed in the student book in the section "Parts of a banknote counter"

Answers to application activity 8.1

- 1) For the definition of banknotes only counter, refer to the student book in the section "8.1. Banknotes only counters"
- 2)The parts of a banknote only counter are shown in the student book in the section 8.1. Banknotes only counter
- 3)Students do a research to come up with the internal parts of a banknote only counter
- 4)Students do a research to identify 5 different banknotes only counters and their specifications.

Lesson 2: Billing machines

a) Learning objective

Explain the working of billing machines

b) Teaching resources

For this lesson to be conducted effectively, the following resources are needed:

- An image or a chart of a billing machine
- A projector to be used to display the first interface of EBM Version 2

c) Introduction

The lesson is introduced by doing the activity 8.2. The teacher guides students so that they come up with answers which will lead them to discovering the

lesson title. The teacher may also narrate a scenario which can be used as an introduction to this lesson

d) Learning activities

Guidance

- The teacher narrates a scenario in which he shows that billing machines are needed
- With active participation of students, the teacher navigates the content of the lesson.
- The teacher makes students discover the advantages of using billing machines by using questions and answers.

Answers to activity 8.2

- 1) Supermarkets use billing machines to produce bills. There are various machines of this kind. A supermarket owner uses the one that will allow to achieve all the functionalities she/he wants.
- 2) The students will give the steps supermarket staff will go through in order to make a bill
- 3) On a bill there is information related to the seller (supermarket), information related to the client, information related to the goods bought and that related to the price to pay.
- 4) Students give the advantages of billing systems in a) stock management and b) paying taxes

Answers to application activity 8.2

- 1) Billing machines use the technology of thermal printing process. For details on this refer to the student book in the section "8.2.Billing machines".
- 2) A billing machine has three main parts which play 3 main roles namely inputting data (keyboard), processing data and outputting information (printer and screen)
- 3) EBM Version 2 is a software introduced by RRA which can be installed on computers and thereafter be used to print bills.

Lesson 3: Note detector

a) Learning objective

Explain the working of note detectors

b) Teaching resources

For this lesson to be effectively conducted the following resources are needed:

- The student book or any other book with the content about note detector
- An image or a note detector or a real note detector if it the teacher can get one.

c) Introduction

- The teacher creates a scenario in which he/she illustrates the need detecting fake notes
- Students say real stories they know of the cases where fake notes were found. If they can't, the teacher gives his/her examples
- Students discover that to prevent fake notes entering in money circulation they use note detectors

d) Learning activities

Guidance

- The teacher introduces the lesson by making learners do the activity 8.3 or he narrates a scenario which illustrates why fake notes detection is necessary
- With questions and answers, students discover the title of the new lesson
- The teacher explains the working principle of different note detectors but he/ she makes sure students also participate in this. If possible, students are the ones who should explain those working mechanisms.

Answers to activity 8.3

- 1) If note detection is done manually, the following are the common features to check:
 - Watermark: Hold a note on a light to see a hidden image
 - Security thread: This is a thin ribbon that is threaded in the note's paper.
 - Intaglio printing: This is a kind of printing which makes raised lines which can be felt by touching the note
 - Etc
- 2) The bank will buy a note detector.
- 3) The advantages of using a bank detector is that you avoid getting fake money. Fake money is a loss and can cause problems to individuals if they receive the fake notes and are cought trying to use them in transactions.

e) Answers to application activity 8.3

- 1) Note detectors use one of the two methods: Ultraviolet light or Magnetic counterfeit bill detection. Students explain how these methods work by referring to the student book in the section "8.3. Note detector".
- 2) Students do research to identify the parts of a note detector.

Lesson 4: Automatic Teller Machine

a) Learning objective

Explain the working of an ATM and use it

b) Teaching resources

For this lesson to be efficiently conducted the following teaching and learning materials are needed:

- An image of an Automatic Teller Machine with its different parts
- The student book or any other book which has some content about ATM
- Projector to display a video on how ATM works

c) Introduction

- The teacher creates a scenario in which he/she illustrates the need for having an Automatic Teller Machine
- Students answer questions on the story heard. They discover that an ATM is the one that can be used to solve the problems stated in the teacher's story.
- Students discover the lesson title

d) Learning activities

Guidance

- Use a story or the activity 8.4 to introduce the lesson
- Show an image of an ATM and make students discover its parts and their names
- Make students explain how to use an ATM to withdraw or deposit money and make them outline the advantages of using an ATM

Answers to activity 8.4

- 1) Referring to their own experience, student explain how to withdraw or deposit money in a bank
- 2) A machine that can act as a bank teller is Automatic Teller Machine.
- 3) The process of withdrawing and depositing money can be found in the student book in the section "7.4. Automatic Teller machine"

Answers to application activity 7.4

- 1) Students do a research on the internet and identify the internal parts of an ATM
- 2) An ATM can be hacked. Students explore what this hacking can have as consequences.

8.6 Skills lab 6

For this lab, students will be able to use different ICT tools in accounting

Guidance to the lab:

This lab may be conducted in class by bringing in class the different ICT tools on which students are going to carry out their activities. It can also be conducted at

the places where those tools are found such as banks

i) Build

Before the lab activity start make sure there is a form that will be used to collect observations by students

- Using questions and answers make learners recall how to use the different ICT tools used in accounting.
- First make students discuss what they are going to do in the skills lab and make them write down what they will ask to the bank agent. In case this is to be done in the classroom, different students will act bank agents who will then answer the questions from other students.

ii) Practice

- Students ask questions using the questionnaire they prepared in advance.
 They will be in groups so that each group as their questions
- Each student should take notes on the findings of the interview.
- After the interview there is a demonstration of how the different ICT tools are operated. Thereafter students use also those tools
- Moderate the conversations and the practice to allow learners capture more experience from the bank agent.

iii) Presentation

Inform students when they will present their skills lab findings. They can use group presentations or any other method such as gallery work. During the presentations other students challenge the presenting team.

iv)Conclusion

The conclusion is going to be done by every student. The teacher will randomly select a student who says the point he/she has captured from the presentation and the whole skills lab activity. The main points given by students are written on the blackboard.

8.7 Additional information for teachers

It is good to teach this unit using the tools related to each unit namely counting machines, billing machines, note detector, Automatic Teller Machine. These tools are not easy to find but the teacher can use other alternatives available namely watching images or videos of those devices and visiting an institution where those devices can be found like banks.

8.8 End unit assessment

- 1) Students do research to identify the benefits of using IVT tools in Accounting.
- 2) The ICT tools seen throughout the unit are counting machines, billing machines, note detector and Automatic Teller Machines. Students describe those tools in their own terms by referring to the content in the student book in the corresponding titles.
- 3) There are different software used in accounting such as QuickBooks, Sage, Wave, Xero, FreshBooks, etc. Students describe those software.

8.9 Additional activities

8.9.1 Remedial activities

- 1) Define the following terms:
 - a) Banknotes only counter
 - b) coin sorter
 - c) ATM
- 2) What are the three main parts of a computer. Identify those three parts on an ATM if possible
- 3) What is a billing machine?

Answers:

- 1) For the definitions in question 1 refer to the student book in the section "8.1. Counting machines" and "8.4 Automatic Teller Machine".
- 2)The three main parts of a computer are input, output and Central processing unit. On an ATM the input part is the keypad, the output is the screen and the central processing unit is the circuitry of the ATM which are housed inside its case.
- 3) For the definition of a billing machine refer to the student book in the section "8.2. Billing machines"

8.9.2 Consolidation activities

- 1) Draw and label the parts of a banknotes counter
- 2) Explain EBM Version 2

Answers:

- 1) For the labels of a banknotes counter refer to the student book in the section "A. Parts of a banknote counter"
- 2) For the definition of EBM Version 2 refer to the student book in the section "Billing machines in Rwanda"

8.9.3 Extended activities

- 1) Explain how EMB machines used by business owners facilitate in the following:
 - a) Stock management
 - b) Taxes calculations and collection
 - c) Profit calculation
 - d) Daily sales
- 2) There are banknotes only counters which can also detect fake notes. Explain how they work

Answers:

- Students explain how EBM improve stock management, taxes calculations and collection, profit calculation and daily sales. To get explanation on this they do a research on the internet and refer also to the student book in the section "8.2. Billing machines".
- 2) Student also do a research on banknotes only counters which can also detect fake notes. They use the same mechanism as note detectors. Refer also to the student book in the section "8.3 Note detector".
